/ Fronius is a family-run company and has remained privately owned for more than 70 years.

/ Fronius International GmbH has been researching new technologies for converting electrical energy since 1945. That amounts to seven decades of experience, progress and continuous innovation. The company is based in Pettenbach, Upper Austria and in addition to its Solar Energy Division, it is internationally successful in the fields of perfect charging and perfect welding. This enhances the strength and stability of Fronius.

/ Fronius thinks in terms of long-term growth, not quarterly figures. In contrast to listed companies, Fronius is not governed by any compulsion for short-term profit maximisation. As a family company, our corporate activity is based on dealing with resources responsibly.

FRONIUS IN FIGURES

/ In 2015, profits earned by Fronius amounted to tens of millions. Dun & Bradstreet (D&B), the world's largest service provider of business-to-business trade information, assigned a risk indicator of 1* to Fronius. Only companies with a high security factor are assigned such a positive indicator. The average risk indicator for the industry stands at 2.3. D&B also awarded a score of 100 (out of 100) to Fronius. This figure represents a very low insolvency risk.
